Foreign language (English) written examination is not administered by the University of Tokyo to applicants for the Master's Program, Graduate School of Medicine, the University of Tokyo. In lieu of those examinations, applicants are required to submit an official report of their TOEFL or IELTS scores as below. As written in the NOTES, TOEFL or IELTS score submission may be exempted. TOEFL or IELTS score submission may be exempted if any of the following (1) or (2) apply.

- (1) An applicant who earned or is expected to earn a bachelor's degree, or the international equivalent thereof, from an institution, where the primary language of the entire institution (not only the applicant's department or program) is English, in Australia, Canada, Ireland, New Zealand, the U.K. or the U.S.A.
- (2) An applicant who earned or is expected to earn a bachelor's degree, or the international equivalent thereof, from an institution, where the primary language of the entire institution (not only the applicant's department or program) is English in countries other than Australia, Canada, Ireland, New Zealand, the U.K. or the U.S.A. If an applicant falls into this category, he/she is required to send a certificate of medium of instruction issued by the institution by mail.
- X Both (1) and (2) are limited to bachelor's program only. NOT apply to master's and doctoral programs.
- * Those who wish to be exempted from submitting scores should contact administrative staff (email: in.m@gs.mail.u-tokyo.ac.jp) by the end of May 2023.




